B.3. Type of allocation of quota places

The quota places are allocated to the NOC through Olympic Qualification Ranking (OQR) and Continental Qualification Competitions. The athlete quota places selected for the Olympic Games are not tied to the specific athlete who obtained the place on behalf of the NOC.

B.4. Maximum Entries at the Olympic Games in Los Angeles 2028

B.4.1. An NOC can enter a maximum of two (2) boats per event at the Olympic Games Los Angeles 2028.

B.4.2. Athletes must compete in the event(s) that they are entered in by their NOC by the time of Sport Entries Deadline. Athletes can compete in more than one (1) event in the same category (e.g. Men's Canoe, Women's Canoe, Men's Kayak and Women's Kayak) but cannot compete in another category. The maximum number of athletes entered in a category of the relevant gender is set in table B.2.

B.5. Minimum Entries at the Olympic Games in Los Angeles 2028

B.5.1. All athletes selected by an NOC must compete in at least one event at the Olympic Games Los Angeles 2028. DNS (Did Not Start) is not a valid result, as the athlete would not have competed.

B.5.2. At the Olympic Games Los Angeles 2028, NOCs with

two (2) confirmed quotas in the same category must participate in a minimum of two (2) events in the respective category;

three (3) confirmed quotas in the same category must participate in a minimum of two (2) events in the respective category;

four (4) confirmed quotas in the same category must participate in a minimum of three (3) events in the respective category;

five (5) confirmed quotas in the same category must participate in a minimum of three (3) events and two (2) boats must participate in the singles event (K1) in the respective category;

C. ATHLETE ELIGIBILITY

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of ICF, may participate in the Olympic Games LA28.

Additional IF Eligibility Criterion

C.1.1. To be eligible to participate in the Olympic Games Los Angeles 2028, all eligible NOCs must participate in at least one event at any of the Olympic Ranking Competitions or Continental Qualification Competition.

C.1.2. To be eligible for a Universality Place the athlete must be appear on the ICF Canoe Sprint Olympic Qualification Ranking.

C.1.3. In order to be eligible to obtain quotas at a Continental Qualification Competition, the athlete must be eligible to participate in the Olympic Games LA28 by the entry deadline of the given Continental Qualification Competition the latest.

D. QUALIFICATION PATHWAY

D.1. For the purposes of this qualification system, "Continental Qualification Competitions" shall refer to the following:

- a) European Olympic Qualification Competition
- b) Pan-American Olympic Qualification Competition
- c) Asian Olympic Qualification Competition
- d) African Olympic Qualification Competition
- e) Oceania Olympic Qualification Competition

D.1.1. The order of quota distribution is quota allocation based on Olympic Qualification Ranking positions first, direct qualification from Continental Qualification Competitions second.

D.2. Distribution of quotas by Olympic Qualification Ranking and at the Continental Qualification Competitions

D.2.1. The initial distribution of quotas based on the OQR positions and Continental Qualification Competitions' results will be as set out below, subject to:

- I. the limits on maximum number of quotas as specified in B.2 above; and
- II. any subsequent reallocation of quotas in accordance with the provisions of this Qualification System.

D.3.3. The order of allocating quotas from the Olympic Qualification Ranking
 Quota allocation in the kayak categories begins with the K4 quotas, which is followed by the K2 quotas and K1 quotas are the last ones to be allocated.
 Quota allocation in the canoe categories begins with the C2 quotas, which is followed by the C1 quotas.

D.4. Continental Qualification Competitions – Refer to ANNEX

D.4.1. Only those NOCs are eligible to enter boats in a category at the Continental Qualification Competitions, which have not obtained any quotas from the OQR in the respective category.

D.4.2. An athlete may compete in one (1) or more events at a Continental Qualification Competition.

D.4.3. However, an athlete may obtain only one (1) quota for their NOC by direct qualification at the Continental Qualification Competitions.

D.4.4. Should any quota at a Continental Qualification Competition need to be determined other than by the results of direct competitions between athletes in the same race, the distribution of quotas will be to the athlete(s) with the fastest time in the preceding phase of the event.

D.4.5. In case the quota at a Continental Qualification Competition is determined by direct ranking and the results on the last qualifying position are tied, the respective Event Ranking standings at the locking of the OQR will be observed to break the tie.

D.4.6. A minimum of three (3) NOCs must contest each quota at the Continental Qualification Competitions for the event to be eligible. If there are less than three (3) NOCs in an event, then the quota(s) will be reallocated to Olympic Qualification Ranking according to the following:

1. In K2/C2 events, the available quotas will be allocated to the next eligible ranked NOC on the K2/C2 Event Ranking, omitting the NOCs which already obtained at least one (1) quota from the OQR in the respective category.
2. In K1/C1 events, the available quotas will be allocated to the next highest ranked eligible NOCs on the K1/C1 Event Ranking, omitting the NOCs which already obtained two (2) quotas in K2/C2 events at the Continental Qualification Competitions in the respective category or already obtained at least one (1) quota from the OQR in the respective category.

D.4.7. The initial distribution of quotas available at the Continental Qualification Competitions will be as set out in the table below, subject to:

- (i) the limits on maximum quotas as specified in B.2. above; and
- (ii) any subsequent reallocation of quotas in accordance with the provisions of this qualification system

The host country must compete in the respective category (i.e. Men's Kayak, Women's Kayak, Men's Canoe and Women's Canoe) at the 2027 Canoe Sprint World Championships to be eligible, plus they must comply with the requirements outlined in section C. Athlete Eligibility of this document.

D.6.**Universality Places****2 athletes**

(total 2 athletes)

Two (2) Universality Places in single boats are made available to eligible NOCs at the Olympic Games Los Angeles 2028 in the sport of Canoe. These places can be attributed to Canoe Sprint or Canoe Slalom athletes.

To be eligible for a Universality Place the athlete must be appear on the ICF Canoe Sprint OQR.

On 1 October 2027, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality Places. The deadline for NOCs to submit their requests is 15 January 2028. The Tripartite Commission will confirm, in writing, the allocation of Universality Places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on Universality Places is contained in the "Los Angeles 2028 Olympic Games - Tripartite Commission Universality Places - Allocation Procedure" document.

E. CONFIRMATION

Confirmation of Qualification Places

E.1. Within 10 days following the date of conclusion and publication of the OQR, the ICF will inform the respective NOCs of their allocated quota places. The NOCs will then have up to 5 working days from that notification to confirm to the ICF:

- That they wish to accept their allocated quota(s) or to return them to the ICF for reallocation to another NOC;
- Where they need to return provisionally allocated quota(s) in accordance to B.2 above; or

If a quota place is not accepted within the required time frame, the quota(s) will be returned for reallocation as outlined in section F.1 Reallocation of Unused Quota Places.

Confirmation of Host Country Places

E.2. The host country must confirm in writing to the ICF within 5 days after their last qualification competition the use of its host country places.

F. REALLOCATION

Reallocation of unused Qualification Places

F.1. F.1.1. Olympic Qualification Ranking

If an allocated quota is not confirmed by the NOC by the confirmation of quota place deadline or is declined by the NOC, the quota will be reallocated to the next highest ranked eligible NOC, not yet qualified, from the respective Event Ranking, according to B.2. This process will be repeated until all places are allocated. To the same event.

F.1.2. Continental Qualification Competitions

F.1.2.1. If one or more allocated quota from the Continental Qualification Competitions is not confirmed by the NOC by the confirmation of quota deadline or is declined/returned by the NOC then the quota will be reallocated to the next highest ranked eligible NOC in that event, not yet qualified. This process will be repeated until all quotas are allocated.

F.1.2.2. In the case where there are no more eligible NOCs that can obtain an athlete quota from the Continental Qualification Competitions, the highest ranked eligible NOC from that continent on the respective Event Ranking, not yet qualified, will be allocated the quota(s).

F.1.2.3. In the case there are no more eligible NOCs from a continent to obtain a place from the Event Ranking, the quota place will be allocated to the next highest ranked eligible NOC from the respective Event Ranking, not yet qualified, regardless of continental representation.

F.1.2.4. If an athlete quota place is not filled from the procedures outlined above, the ICF Executive Committee will then reallocate the remaining quota place to the next highest ranked eligible NOC, not yet qualified in the sport of Canoe Sprint based on OQR.

Reallocation of unused Host Country Places

F.2. Where the host country obtains a quota in any category, the unused host country place will be reallocated to the next highest placed, unqualified eligible NOC on the K1/C1 Event Ranking in the respective category.

Reallocation of unused Universality Places

F.3. Any unused Universality place(s) will be reallocated to the next highest ranked eligible NOC from the ICF Canoe Sprint OQR that has not yet qualified any athlete quota in the sport of Canoe (Canoe Sprint, Canoe Slalom).

H. ANNEX

H.1. Principles of the Olympic Qualification Ranking:

- The ranking period runs from 4 May 2026 to 31 December 2027
- Points are awarded with the following multipliers:
 - o 2026 and 2027 World Championships 1,5x
 - o 2026, 2027 World Cups 1x
 - o 2026, 2027 Continental Championships 1x (2 competitions/continent, to be defined in section G – Qualification Timeline)
- The full list of Olympic Qualification Ranking Competitions is outlined in paragraph G.
- On the Event Rankings the maximum of eight (8) best results (highest points) of each eligible nation are counted for during the ranking period.
 - o these eight (8) results must be from eight (8) different competitions
 - o out of these eight (8) best results the maximum of six (6) results are counted from competitions held on the same continent.
- If there are more than one boat entered in the same event from the same nation at the same competition, only the better placed boat may earn points.
- In the crew-boat categories Event Ranking points can be earned only in the respective events (K4-K4 500m; K2-K2 500m; C2-C2 500m). In the single-boat categories all single-boat events on the programme of the Olympic Qualification Ranking Competitions are counted for points, but at one competition only the best single-boat result (highest point) of each nation counts for the Event Ranking.

- If an athlete is suspended or banned because of any anti-doping related reason or subject to other disciplinary sanctions, all Olympic Qualification Ranking points will be annulled for the athlete concerned and for the crew boats he/she raced in. The points for NOCs ranked after will be re-attributed.
- If two (2) or more NOCs have equal points on the Event Ranking, the following tie-breaker rules decide in ranking them:
 1. The NOC with the higher registered ranking point on the respective Event Ranking from the 2027 Canoe Sprint World Championships will rank higher.
 2. The NOC with the higher registered ranking point from any results on the respective Event Ranking will rank higher.
 3. The NOC with the higher most recent ranking point on the respective Event Ranking will rank higher.
 4. The NOC with the higher overall points calculated from their three most recent ranking points on the respective Event Ranking will rank higher.

H.1.2. The distribution of K4 quotas

Men and women quota allocation is identical.

The top eleven (11) NOCs from the K4 Event Ranking are allocated 4 quotas each. These NOCs must be from at least four (4) continents.

H.1.3. The distribution of K2 and C2 quotas

Men and women quota allocation is identical.

NOCs that obtained K4 quotas are ineligible to obtain quotas from the K2 Event Ranking.

The top four (4) NOCs from the K2 Event Ranking will be allocated two (2) quotas each.

The top eight (8) NOCs from the C2 Event Ranking will be allocated two (2) quotas each.

H.1.4. The distribution of K1 and C1 quotas

Men and women quota allocation is identical.

The top six (6) NOCs from the K1 Event Ranking will be allocated one (1) quota each.

Of all the NOCs that obtained K4 quotas in one category, a maximum of five (5) NOCs/category are eligible to obtain an additional K1 quota in the respective category. In case this number is reached, the K1 quota is allocated to the next highest ranked eligible NOC with less than four (4) quotas in the same category.

The top five (5) NOCs from the C1 Event Ranking will be allocated one (1) quota each.

H.1.5. In the situation that the OQR needs to be locked at an earlier date than December 31st, 2027, the Olympic quota allocation will be based on reverted standings to the termination of the previous full season (December 31st of the previous year). In this case the number of Continental Qualification Competitions considered for the OQR must be equal for all continents.

H.2. Principles of the Continental Qualification Competition:

H.2.1. K2 events and C2 events (Men and Women)

Each continent will be allocated two (2) quotas for double boats to be obtained at each Continental Qualification Competition. These two (2) quotas will be allocated in each event to the highest-placed eligible NOCs.

H.2.2. K1 events and C1 events (Men and Women)

Europe, Pan-America and Asia will be allocated two (2) quotas for single boats to be obtained by the top two eligible finishers at their respective Continental Qualification Competition. For the African and Oceanian continents, there will be one (1) quota given to the highest-placed eligible NOCs at their respective Continental Qualification Competition.

H.2.3 Reallocation of quotas released through “doubling ups” in different events

If an athlete qualifies for more than one (1) quota in K2/C2 and K1/C1 at the Continental Qualification Competition, the athlete's NOC will be allocated only one (1) of these quotas. This shall be the quota in K2/C2. The released quota will be allocated to the next highest ranked eligible NOC not yet qualified in the K1/C1 events of the same category.

H.2.4. Maximum Quota places at Continental Qualification Competitions

An NOC can qualify a maximum of two (2) quotas in each category, that is, Kayak men, Kayak women, Canoe men and Canoe women at the Continental Qualification Competitions. The unused quota in any category will be allocated to the next highest ranked eligible NOC not yet qualified in the K1/C1 events of the same category.

H.2.5. In the situation that a Continental Qualification Competition cannot be held, the Olympic Qualification Ranking will be used to determine the quotas for that continent. Quotas will be allocated to the respective continent, for which the Continental Qualification Competition could not be held, in accordance with D.4.7. In such cases, the order of allocation is the following:

1. Two (2) quotas will be allocated to the highest ranked, not yet qualified eligible NOC of the respective continent on the K2/C2 Event Ranking in each category, omitting the NOCs which already obtained at least one (1) quota from the Olympic Qualification Ranking in the respective category. In case of Africa and Oceania, one (1) quota will be allocated to the highest ranked, not yet qualified eligible NOC of the respective continent on the K1/C1 Event Ranking in each category, omitting the NOCs which already obtained at least one (1) quota from the Olympic Qualification Ranking in the respective category. In case of Europe, Pan-America and Asia, two (2) quotas will be allocated to the two eligible ranked, not yet qualified NOCs (one each) of the respective continent on the K1/C1 Event Ranking in each category, omitting the NOCs which already obtained at least one (1) quota from the Olympic Qualification Ranking in the respective category.

***Doubling Up:** when an athlete achieves the qualification in more than one boat, he/she will only be counted once on the athlete quota, allowing another athlete to be allocated a quota.
