### B.3. Type of allocation of quota places

The quota place is allocated to the National Olympic Committee (NOC).

## C. ATHLETE ELIGIBILITY

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of the UWW, may participate in the LA28 Olympic Games.

### Age requirements

**C.1.** To be eligible to participate in the LA28 Olympic Games, athletes must have been born on or before 31 December 2010 (i.e. be at least 18 years old or reaching this age in 2028), as validated by the passport used for accreditation registration.

### Additional IF requirements

**C.2.** To be eligible to participate in the qualifying events and in the LA28 Olympic Games, all athletes must hold a valid license issued by their National Wrestling Federation and be recorded in the UWW's official database.

## D. QUALIFICATION PATHWAY

<b>D.1.1.</b> <b>48 Men</b> <b>24 Women</b> <b>72 Athletes</b>	<b>QUOTA PLACES</b> <b>1st phase – 2027 Senior World Championships</b> Only athletes whose NOC took part in the 2027 Senior Continental Championships will be able to participate in the 2027 Senior World Championships with the same number of athletes per style.

The medallists (gold, silver, bronze and bronze) from the 18 Olympic weight categories at the 2027 Senior World Championships will each obtain one quota place for their NOC for the LA28 Olympic Games.

#### D.1.2.

##### **2nd phase: Ranking System**

**36 Men  
18 Women**

The first three athletes of the UWW Rankings, not qualified in the first phase, will obtain one quota place for their NOC for the LA28 Olympic Games.

**54 Athletes**

The UWW Rankings will include the seven main events organised before the LA28 Olympic Games:

- 2027 Senior Continental Championships\*
- 2027 Ranking Series (3 events)
- 2027 Senior World Championships
- 2028 Ranking Series (1 event)
- 2028 Senior Continental Championships\*

*\*Continental Games might be added to the ranking events. Because some continents might not have their Continental Games included in the UWW Rankings, the same number of ranking events will be considered for each country. Therefore, if a specific Continental Games is included in the UWW Rankings, we will take only the two best results out of the three continental events (Continental Games, 2027 Continental Championships and 2028 Continental Championships). A specific circular will be sent to all NFs when the final decision is taken with each Continental Games entity.*

#### D.1.3.

##### **3rd phase: 2028 Continental Qualification Tournaments**

**96 x Men  
48 x Women**

Each continent will organise a specific Olympic Qualification Tournament with the exception of Oceania and Africa which will have one joint Qualification Tournament.

**144 x  
Athletes**

Athletes who obtained quota places for their NOC in the two first phases will not have the right to participate in the Continental Qualification Tournaments of this 3rd phase, except if they compete in another wrestling style. The NOCs/NFs will not be able to send other athletes in the weight categories in which they have already qualified a quota place.

The two highest placed athletes at each Continental Qualification Tournament in each of the 18 Olympic weight categories will obtain one quota place each for their NOC for the LA28 Olympic Games.

**D.1.4.****12 Men  
6 Women****18 Athletes****4th phase: 2028 World Qualification Tournament**

NOCs that already obtained a quota place in the first phases, across all styles, will not have the right to take part in this 4th qualification phase.

Only the NOCs/NFs that did not obtain a quota place during the first phases, may participate in this 4th phase. These NOCs/NFs will be allowed to register a maximum of two athletes, across all styles.

The highest ranked athlete in each of the 18 Olympic weight categories will obtain one quota place for their NOC for the LA28 Olympic Games.

**D.2.****HOST COUNTRY PLACES**

No host country places will be allocated for wrestling.

**D.3.****UNIVERSALITY PLACES**

In wrestling, no universality quotas will be directly allocated as part of the athletes' quota.

Universality places may be offered to NOCs within the reallocation process for unused qualification places in individual events, once the initial quota allocation has been completed, as described in paragraph **F. Reallocation of Unused Quota Places**.

On 1 October 2027, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality Places. The deadline for NOCs to submit their requests is 15 January 2028. The Tripartite Commission will confirm, in writing, the allocation of Universality Places to the relevant NOCs after the end of the qualification period for the sport concerned.

## E. CONFIRMATION

### Confirmation of quota places

E.1. Following each qualification event, UWW will publish the results on its website and inform the respective NOCs of their allocated places.

The quota places allocated based on the UWW Rankings will be finalised right after the last events included in the UWW Rankings.

The NOCs will then have two weeks to confirm if they wish to use these quota places, as detailed in paragraph **G. Qualification Timeline**.

## F. REALLOCATION

### Reallocation of unused quota places

#### F.1. 1<sup>st</sup> and 3<sup>rd</sup> qualification phases:

If an allocated quota place is not confirmed by the NOC by the confirmation of quota place deadline, or is declined by the NOC, the quota place will be reallocated to the next highest-ranked eligible NOC, not yet qualified, at the event at which the quota place was obtained, respecting the maximum quota per gender and per NOC.

If a weight category has less than eight athletes and the quota place has to be reallocated, it will be reallocated to the universality place.

#### 2<sup>nd</sup> qualification phase:

If an allocated quota place is not confirmed by the NOC by the relevant deadline, or is declined by the NOC, the quota place will be reallocated to the next highest-ranked eligible NOC in the UWW Rankings, not yet qualified, respecting the maximum quota per gender and per NOC.

#### 4<sup>th</sup> qualification phase:

If an allocated quota place is not confirmed by the NOC by the relevant deadline, or is declined by the NOC, the quota place will be reallocated to the universality places.

### Reallocation of unused universality places

F.2. If the NOC does not confirm the use of a quota place allocated through universality places by the relevant deadline set by the confirmation of accepting quota, the universality place will be reallocated to the next highest ranked eligible athlete of the same gender and event in the UWW Rankings, who has not yet qualified for the LA28 Olympic Games, respecting the maximum quota per gender and per NOC.
